**CANDIDATE PROBATION**

Prospective members (candidate) will be required to serve a probation period of 6 months. During the probation period the prospective member will be expected to:

- Respond to as many calls as possible, 100% of trainings and 100% of member meetings
- Minimum of 36 hours of shift time at the station(s) a month. (A shift will be a minimum of eight (8) hours unless other arrangements with the Fire Chief have been made)
- Respond only to the station and not directly to the scene
- Complete the Department driver training program (if over the age of 21).
- Complete CPR training
- Complete Blood Borne Pathogen training
- Complete Department Task Book
- Read, learn and know ALL Standard Operating Procedures (SOPs) and Standard Operating Guidelines (SOG)s
